The Juvenile Crime Prevention Council (JCPC) has studied the risk factors and needs of Juvenile Court involved youth in this county and hereby publishes this Request for Proposals. The JCPC anticipates Raise the Age Expansion funds from the NC Department of Public Safety, Division of Adult Correction and Juvenile Justice, Community Programs section in the amount stated above to fund and/or expand the program types specified below. Such programs will serve delinquent and at-risk youth for the state fiscal year 2019-2020 beginning on, or after, July 1, 2019. The use of these Raise the Age Expansion funds in this county do not require a local match for the first year ONLY. These expansion funds are an addition to the funds previously allocated in the amount of \$104,212.

The JCPC will consider proposals for the following needed programs:

Proposed program services should target the following risk factors for delinquency or repeat delinquency:

The elevated number of youth over the age of 12 who are at risk of committing their first delinquent offense. The elevated number of youth with prior referrals at intake. The elevated number of youth who have known use of alcohol and/or illegal drugs. The elevated number of youth who have school behavior problems. The elevated number of youth who lack pro-social peers. The elevated number of youth who lack parents that are able to supervise them.

Programs should address the following concerns as reported in the Needs Assessments for adjudicated youth:

- Peer Domain: An increased number of youth who associate with others involved in delinquent activity.
- Individual Domain: An increased rate of abuse/neglect, a lack of support of victims of abuse/neglect. Elevated rate of substance abuse.
- Family Domain: Conflict in the home. Inadequate supervision at home. Famil Substance Abuse. Family Criminality.
- School Domain: High levels of school behavior problems. Functioning below grade level.

Applicants are being sought that are able to address items below:

1. Program services compatible with research that are shown to be effective with juvenile offenders.
2. Program services are outcome-based.
3. The program has an evaluation component.
4. Program services detect gang participation and divert individual, if applicable.

Local public agencies, 501(c)(3) non-profit corporations and local housing authorities are invited to submit applications to provide services addressing the above elements.
