**RESPONSIBILITIES:** This position provides protective and/or in-home services for children under age 18. Investigation includes the gathering of data concerning the children and family from schools, community, and extended family members. Work involves counseling with families to prevent or resolve problems leading to abuse or neglect, and making referrals to other community resources as needed.
