MINUTES

CALL TO ORDER

- I. WELCOME: Chair Shelly Webb called the meeting to order at 2:00 PM. Shelly Webb, Sara Daughtry, Greta Gosnell, Deb Haight, Carla Hill, Sabrina Griffin (in place of Elaine Russell), Jeff Adams, and Traci McCormick were present. Absent was Hunter Jones and Amy Marquez (excused). A quorum was present. Darby Terrell, Planner was present as well.
- **II. AGENDA MODIFICATIONS:** There were no proposed agenda modifications.

Ms. Greta Gosnell motioned to approve the minutes and consent agenda as presented, seconded by Ms. Sara Daughtry. The motion passed unanimously.

IV. NEW BUSINESS: Presentation Slides

Ms. Terrell went over the organizational statistics for the previous quarter, and while presenting. Ms. Terrell also informed the board of the new minivan that has been in operation for two weeks. Every person that has taken a ride in the new minivan has raved to the Driver on its great experience. With the still slow uptick of the Fixed Route ridership, using the minivan and other vans to increase ridership is a focus for staff. The members discussed the presented data.

B. Fixed Route Rerouting Recommendations
 Mr. Adams presented to the board that staff were looking into up to three different route changes. With the help of Ms. Terrell, staff presented all three

options and took feedback from the board. The board discussed the information presented and asked clarifying questions to staff. There was a suggestion by a board member to change the route when going toward the Pisgah Forest area stops. The suggestion was to use the back way into the Forest Gate Shopping Center using US276, to stop at the Hub stop location first near Pizza Hut, then travel to the Forest Gate Shopping Center stop location next going through the old Bi-Low parking lot, to make a faster time that would not be hindered by the seasonal traffic. After much discussion and with a few members having to leave during the meeting the remainder of the members reached a consensus on going with option three with the discussed changes to the route.

C. Bylaw Review: Changes Discussion

Ms. Terrell presented the suggested changes to the bylaws that overlapped with the other counties' TAB bylaws as discussed at the previous meeting. When discussing the updated draft bylaws, there was a suggestion to add to the new quorum definition wording: "seats vacant for two (2) consecutive meetings are considered inactive and should/may not be counted against the quorum at the next meeting." There was a consensus by the board to include this suggested change to the bylaws at the next meeting to be voted on.

D. Land of Sky – RPO

Ms. Eastland informed the board NCDOT Prioritization is beginning and should be ready for local input in the next month or so. There is a new process that is being adopted by Land of Sky that will be assessed to make sure they are in line with what NCDOT requires. Ms. Eastland gave an update on the funding issue with the to be built Park n Ride in Pisgah Forest. She was able to get NCDOT to agree to pay and build the parking lot, but the County would have to pay for the installation of the bus shelter at the site. This can easily be applied for in the upcoming years for Capital Funding or have help from other organizations.

She also updated the board on the Regional Transit study that is being conducted by Land of Sky, currently they are looking into options of connecting the County to Henderson's transit with a route to Hendersonville, or a route to Asheville Airport which connects to multiple transits in the region. Mr. Adams informed Vicki there has been discussion already with the transportation staff and Henderson County's transit staff for a stop or connection in Etowah. Ms. Eastland asked to be copied on further communication and meetings to be in the loop.

V. BOARD MEMBERS' COMMENTS:

Jeff Adams- He stated he would like to thank everyone for showing up and giving the feedback for the Rerouting options for the Fixed Route. They would take their input for the next phase of having public comment, and County Commissioner review.

Mr. Jeff Adams motioned to adjourn the meeting at 3:34 PM, seconded by Sarah Daughtry.

Background

Since it is the beginning of the new fiscal year, staff wanted to present to the Transportation Advisory Board the breakdown of ridership for both Demand Response and Fixed Route services. This allows the members to have a more wholistic view of the numbers they are presented each quarter on the operational statistics. Staff wish for this to be an update only. Staff only wishes to highlight for the Demand Response the past two years have rebounded from the COVID years. Though Operations staff would like to point out it still isn't as high of ridership as pre-COVID. For the Fixed Route staff wishes to highlight that we still haven't increased ridership over 5,000 per year, and in fact this past year we have seen a slight drop. Staff is planning on a Marketing plan for both services throughout this year in hopes to increase ridership all around. All the data comes from our software and is the same information that is presented via graphs and that is put in the Operational Statistics for the state reporting.

Background

Transylvania County Transportation Advisory Board receives each meeting a quarterly report on the operation and revenue data from the previous month. Each time they are given last year's same report to show the yearly difference. For Quarter 4 the months that will be reviewed will be April 2024 till June 2024. Comparing fiscal year 2023 Quarter 4 with last fiscal year 2024 Quarter 4, for the Demand Response with our Vans we spent less hours but more miles and had more passenger trips. For our Cab Demand Response, we had more hours with less miles and passenger trips. We did start the Silver Squirrel Voucher program, as well as started pushing our new Mini Van as another option for riders. For our Fixed Route we spent more hours and miles and had less passenger trips overall.

A-1 Public Hearing Notice for Board of Commissioners Meeting

Background

The Transportation Advisory Board is informed on the next fiscal year's Unified Grant Application to NCDOT's Integrated Mobility Division (IMD). On behalf of rural communities, the NCDOT's IMD completes applications for formula grants for rural areas (Section 5311) and formula grants for the enhanced mobility of Seniors & Individuals with Disabilities and capital improvements for transit systems. This allows rural communities to work directly with their state rather than needing to apply directly for funding through the Federal Transit Administration. There are three grants we apply for each year, those being the 5311 Administrative grants, the Combined Capital Program, and 5310 Operating program. All these grants are funded from the federal funds discussed. TAB is required to review each year's application before submittal. Once TAB has seen the amounts we are requesting, a public hearing must be held and the Board of Commissioners must pass a resolution, because most of the grant funds request a local match from the county's own budget. For this upcoming year FY2026, we will be requesting the following for each grant. It will go to the County Commissioners for a public hearing on September 9, 2024 at 4pm.

FY2024 5311 Administrative

The Section 5311 grant program is apportioned to individual counties based on a formula that considers factors such as land area, population, population growth rates, vehicle miles and the number of low-income individuals. In North Carolina, Section 5311 subsidizes the administrative costs of running a transportation system, allowing communities to focus their resources predominantly on operations.

In this application, Transylvania County Transportation requests a total of \$164,470 in support for the administrative expenditures of its transit program. This requires a County local match of \$24,671 (15%) of the total.

FY2024 Combined Capital Program

Just as NCDOT IMD applies for formula funding through the Federal Transit Administration, it also applies for funding to maintain the fleet of publicly supported transit vehicles and other capital needs.

Transylvania County requests a total of $\frac{$435,000}{}$ in capital funding for replacement for three (3) vans with lifts as well as bike racks. This requires a county match of $\frac{$43,500 (10\%)}{}$ of the total.

FY2024 5310 Operating Program

Transylvania County was successful in the approval of 5310 funds for Fiscal Year 2026. For Fiscal Year 2026, Transylvania County plans to apply for the same amount of \$104,000, this requires a county match of \$52,000 (50%) of the total. The County currently budgets \$52,000 for the purchase of rides through a local private operator.

The 5310 grants have been able to help restore out of County transportation to the elderly and disabled as well as enabling these individuals to travel from unincorporated areas within Transylvania County to incorporated areas of the county.

Standard State match for 5311 Administrative Grant funding is 5% and Combined Capital is 10%. For Fiscal Year 2024, Applicants have been notified by the NCDOT IMD that the local share amount is subject to State funding availability.

Background

For this upcoming school year, the Transportation system would like to review their rule on how old a minor can ride without a parent. Staff specifically wanting to potentially adjust the rule which is currently 16 or older can ride without a parent, anyone younger must have a guardian, parent, or adult with them. In the past we have transported students during the school year who have had classes at Blue Ridge Community College. The transportation staff would like to potentially adjust the rule to allow potential riders under 16. It may be unfeasible for them to have an adult or parent ride with them seeing how they need transportation. Staff wanted to present the idea to the Transportation Advisory Board on having anyone under the age of 16 and their parents sign a consent form allowing them to ride by themselves but outlining how they must follow the rules and them agreeing to the consequences if they do not.

Staff recommend approval of the minor consent form with any adjustments the board sees fit to include.
