#### A. Continuation of CAI# 24-07, Lisa Fletcher, on behalf of the Transylvania County Board of Education is requesting Community Appearance Initiative assistance for 41 Confederate Lane, Brevard, NC.

Mr. Kimsey Jackson and Mr. Greg Cochran recused themselves for this discussion as they are members of the Transylvania County School Board. Mr. Smith explained the potentially hazardous conditions at the property and recommended complete demolition of the structure. Other approved CAI projects have not been completed. The totals from other approved projects may come in under their approved budgets. Other CAI applications, such as CAI # 24-07 can be revisited when the board has a better picture of what funding is still available for projects. Mr. Johnson moved to direct staff to see what projects have expired and if any more funding will be freed in coming months to address other CAI applications. Mr. Privette seconded the motion. All present un-recused members voted in favor and the motion passed.

B. Transylvania County 2050 Comprehensive Plan Update Kick-Off & Community Engagement Report The board briefly discussed their concerns with the bias of public engagement, namely the political affiliations and income disparity of participants. Staff informed the board that some demographics tend to have higher turnouts of public engagement, but the upcoming community survey will be easily accessible to those that were unable to participate during the in-person sessions. <u>Mr. Privette moved to accept the Community Engagement Report and Mr. Johnson seconded. All present members voted in favor and the motion passed.</u>

**C.** Transylvania County 2050 Comprehensive Plan Update Draft Community Survey The board requested more time to review the proposed changes to the community survey. <u>Mr. Johnson moved to table this discussion until the next meeting. Mr. Cochran seconded</u> <u>the motion. All members voted in favor and the motion passed.</u>

#### A. Subdivision & Exemptions Update

#### CALL TO ORDER

- I. WELCOME: Mr. Kimsey Jackson, Planning Board's Vice Chair, called the meeting to order at 6:00PM. Ms. Wendy Warwick, Mr. Mike Privette, and Mr. Herschel Johnson were present. A quorum was present. Mr. Rick Lasater (Chair), Mr. Bramley Fisher, and Mr. Greg Cochran were absent (excused). Mr. Jeff Adams, Ms. Darby Terrell, Ms. Ashley Minery, and Mr. Dwayne Smith were also present.
- **II. PUBLIC COMMENT:** (15-minute time limit. Speakers are limited to three minutes.): There were no public comments.
- III. AGENDA MODIFICATIONS: There were no proposed agenda modifications. <u>Mr. Johnson</u> <u>moved to approve the agenda as presented. Mr. Privette seconded the motion. All</u> <u>present members voted in favor and the motion carried.</u>

#### IV. CONSENT AGENDA:

#### A. Minutes (May 9, 2024)

There was no discussion of the minutes from May's meeting. <u>Mr. Privette moved to</u> <u>approve the consent agenda as presented. Mr. Johnson seconded the motion. All present</u> <u>members voted in favor and the motion carried.</u>

#### V. NEW BUSINESS

#### A. Transylvania County Community Appearance Initiative Visibility Policy Text Amendment

Mr. Adams discussed the proposed text amendments to the Transylvania County Community Appearance Initiative Policy. The previous CAI policy, from the last time the program was active, was geared towards the appearance of scenic corridors in the county. Last year, in the new CAI policy, this was changed to now include any properties that are visible from any state-maintained road. The Planning Board has been hesitant to approve current CAI applications based on their location falling outside the scope of the current CAI policy. After a discussion of previously approved projects, <u>Mr. Privette moved to table this</u> <u>until the next meeting so they can seek further direction from Transylvania County's Board</u> of County Commissioners. Mr. Johnson seconded the motion. All present members voted in favor and the motion carried.

### B. Consideration of CAI# 24-03, John Hoxit requesting Community Appearance Initiative Assistance

Mr. Adams explained the request is for removing junk on the property and the demolition debris of a dilapidated structure. It is located at 95 Tom McKinney Drive. Mr. Smith, of Transylvania County Solid Waste, also explained the owners' motivations for cleaning the property and building a new home in the future. Mr. Smith explained the property owners were covering the labor and the CAI funding would cover the tipping fees for depositing the dumpster contents in the landfill. Mr. Smith quoted \$5250 for these fees, but predicted the final cost would be lower. Mr. Privette moved to allocate up to \$5250 of CAI funds for the Jonathan Hoxit property. Mr. Johnson seconded the motion. Mr. Johnson, Mr. Privette, and Mr. Jackson voted in favor. Ms. Warwick was opposed. The motion carried.

## C. Consideration of CAI #24-04, Rodney Hamilton, on behalf of Christine Hamilton is requesting Community Appearance Initiative assistance.

Ms. Terrell presented the staff report for the Hamilton property. Junk has been collected in an outdoor carport. The property is located at 50 Maple Hill Rd. Mr. Smith also said most of the junk is paper, cardboard, and building materials. He will oversee approved projects to ensure costs remain as low as possible. He estimated \$6700 for the tipping fees of this project, but predicted the final cost would be lower. <u>Mr. Johnson moved to allocate</u> <u>up to \$6700 of CAI funds for the Rodney Hamilton property. Ms. Warwick seconded the</u> <u>motion. All present members voted in favor and the motion carried.</u>

#### VI. INFORMATIONAL OR DISCUSSION ITEMS:

#### A. Subdivision & Exemptions Update

Ms. Minery provided the staff report for the Planning Department's recent approvals. From May 9, 2024, to July 17, 2024, the department approved 9 subdivision applications. This resulted in the creation of 15 new lots. The department also approved 23 subdivision exemption applications. Of these, 15 were for recombination and 6 were for lot line adjustments.

#### **B.** Transportation Update

Ms. Terrell provided recent ridership statistics for the Transylvania County Public Transportation's fixed route and demand response services. The board questioned advertising efforts and possible changes to the fixed route stops. Ms. Terrell explained those changes and the marketing campaign will be a priority of the department in the coming months.

#### **C.** Comprehensive Plan Update

Mr. Adams informed the board of the next steps in the Comprehensive Plan process. Phase 2 of the project will involve drafting goals, strategies and a community survey. This will likely continue through the fall of 2024, with the final phase of the project beginning in 2025. There was high participation in many of the Kickoff Events. So far, Land Use and Livability has been identified as the highest priority focus area. Staff also identified affordable housing, quality healthcare, high paying jobs and education improvement as popular concerns of the community.

**D.** Community Appearance Initiative Update

Mr. Adams explained the CAI funding's is a result of a grant from the Tourism Development Authority (TDA) and is matched by county funds. He also discussed projects that were approved in the past.

E. Housing Study Update

Mr. Adams explained TPMA has received around 500 responses from their surveys so far. These will be available until the end of July.

- VII. **PUBLIC COMMENT:** (15-minute time limit. Speakers are limited to three minutes.) Mr. James Green, a driver for Public Transportation, attended the meeting. He explained that his job exposes him to many types of people around the county. He agreed he often hears concerns about good jobs and housing in the county.
- VIII. BOARD MEMBERS' COMMENTS: Mr. Johnson said his perspective on the scope of the CAI policy is evolving. Mr. Jackson explained he doesn't want people to abuse the program but is glad it does so much good in the community. <u>Mr. Johnson moved to adjourn the meeting. Mr. Jackson seconded the motion. All present members voted in favor and the meeting adjourned at 7:32PM.</u>

#### V. OLD BUSINESS

#### A. Transylvania County Community Appearance Initiative Visibility Policy Text Amendment

Transylvania County Planning is requesting consideration of a text amendment to the Community Appearance Initiative, Scope and Priorities, broadening the scope from the restrictive reading of visibility from State Roadways.

Mr. Adams explained the current standards and regulations of the Community Appearance Initiative (CAI). He presented the board with different options for text amendments including changing the standards or widening the scope of the CAI. The Planning Board discusses if they wanted to change the CAI scope to include any property that abuts a state-maintained road, or if junk should have to be visible from state road (current scope). <u>Mr. Privette moved to leave the CAI scope as it currently</u> <u>reads, and Mr. Johnson seconded the motion. All present members voted in favor and</u>

#### the motion carried.

#### VI. INFORMATIONAL OR DISCUSSION ITEMS:

#### A. Subdivision & Exemptions Update

Ms. Minery provided the staff report for the Planning Department's recent approvals. During the month of July, the department approved 11 total exemptions and 5 subdivisions. Ms. Minery predicted the totals for August would be higher than previous months, based on the approvals at the time of the meeting.

#### **B.** Transportation Update

Ms. Terrell provided recent ridership statistics for the Transylvania County Public Transportation's fixed route and demand response services. There were 107 riders for the Fixed Route service in July. The Demand Response service was consistent with previous years. Ms. Terrell also explained the current survey for public transportation and it's effort to evaluate what the community would like to see in available services.

#### C. Housing Study Update

Mr. Adams announced TPMA's housing study survey received over 500 responses. They will continue to work on the study in coming months.

#### D. Community Appearance Initiative Update

Mr. Adams announced the Hoxit property project was completed and came in under budget. The tipping fees for the project totaled \$2445.90 of the approved \$5250. More applications will likely be brought before the board next month.

#### E. Transylvania 2050 Comprehensive Plan Update

Mr. Adams explained the amended timeline for the 2050 Comprehensive Plan. His goal is to have a survey made available to the public in October. He asked the board to review the current draft survey and bring their editing suggestions to September's meeting. The report from the data collected so far will likely be available to the board next month.

# VII. **PUBLIC COMMENT:** (15-minute time limit. Speakers are limited to three minutes.) There was no public comment.

VIII. BOARD MEMBERS' COMMENTS: Mr. Cochran questioned the number of past CAI projects. Mr. Adams estimated it was over 40, and that number was later confirmed to be over 60. Mr. Fisher expressed his surprise at the average age of participants, so far, have been over 65 years old. He would like to see more young people involved in the Comprehensive Plan and Housing Study process. Mr. Privette moved to adjourn the meeting. Mr. Johnson seconded the motion. AGENDA MODIFICATIONS: As applicants were present for the Community Appearance Initiative (CAI) cases, under New Business, the Planning Board on a motion by Mr. Lasater and second by Mr. Privette proposed agenda modifications to allow the New Business items to immediately follow the consent agenda. The motion carried.
- **IV. CONSENT AGENDA:** There was no discussion of the consent agenda.

#### A. Minutes (August 15, 2024)

There was no discussion of the August meeting minutes. Mr. Fisher moved to approve the minutes as presented. Mr. Cochran seconded the motion. All present members voted in favor and the motion carried.

#### V. NEW BUSINESS

### A. Consideration of CAI# 24-05, Mark Burdett requesting Community Appearance Initiative assistance for 1662 Solomon Jones Road, Cedar Mountain, NC 28718

The applicant, Mark Burdett, on behalf of Garland Blythe, is requesting CAI assistance to remove junk collecting on the premises, along with the demolition debris of dilapidated structure at 1662 Solomon Jones Rd., PID# 9512-75-8783-000, in an un-zoned area of Cedar Mountain. The request will be reviewed under the Community Appearance Initiative policy, as amended on November 27, 2023.

Mr. Adams presented the staff report and explained the current budget for CAI projects for FY24/25. Mr. Burdett, the applicant, provided testimony that the owner and representatives had been before the Magistrate seven times over the past two

years to remove the tenants who damaged the property. <u>Mr. Privette discussed</u> <u>reviewing both CAI cases prior to a decision on either case. Mr. Privette reasoned that</u> <u>since the remaining funding for the year would not cover both applications, they</u> <u>reserve their decisions until after both cases were made. Ms. Warwick moved to</u> <u>review both cases prior to the decision and Mr. Privette seconded the motion. The</u> <u>Board approved unanimously. Following the decision, Mr. Jackson and Mr. Cochran</u> <u>discussed their involvement with the Board of Education and Ms. Warwick moved to</u> <u>recuse Mr. Cochran and Mr. Jackson from the discussion and decision of CAI# 24-07,</u> <u>considering their relationship to the Board of Education. The remaining members</u> <u>unanimously approved.</u>

Ms. Warwick stated both the father and son have disabilities and Mr. Privette confirmed that the property was highly visible from Solomon Jones Road. Mr. Lasater suggested that just as the Confederate Lane property had a history of illegal activities, the same could be said for the Solomon Jones Road property. Ms. Warwick moved to conditionally approve the expenditure of \$10,500, as estimated in the staff report, upon a signed agreement to clean up the property within 30 days from this decision, and the project completed within 60 days from the date of fully executed agreement. Mr. Privette seconded the motion and Chairman Lasater, Mr. Fisher, Mr. Privette and Ms. Warwick voted to approve, with Mr. Cochran and Mr. Jackson abstaining. The motion carries.

# B. Consideration of CAI# 24-07, Lisa Fletcher, on behalf of Transylvania County Board of Education is requesting Community Appearance Initiative assistance for 41 Confederate Lane, Brevard, NC

The applicant, Lisa Fletcher, on behalf of Transylvania County Board of Education, is requesting CAI assistance to remove junk collecting on the premises at 41 Confederate Lane, PID# 8564-62-4660-000, in an un-zoned area of the County. The request will be reviewed under the Community Appearance Initiative policy, as amended on November 27, 2023.

Mr. Adams presented the staff report and Ms. Fletcher, the applicant, provided testimony that the Board of Education became the owners of this nuisance property earlier this year and were hoping to clean up the property so that the School Board could build teacher housing upon the site. The Sheriff's Department provided a letter regarding the suspected drug production and other illegal activities associated with the property over the previous years. <u>Mr. Privette stated his reservations on providing another public entity funds and Ms. Warwick suggested that the Board of Education's partners, such as Habitat, could provide such clean up support. <u>Mr. Lasater motioned for the Board to table the decision, until CAI# 24-05 funding was exhausted and the Board could gauge remaining available funds, Ms. Warwick seconded the motion and the Board unanimously approved to table the item to the regularly scheduled December meeting.</u></u>

#### V. OLD BUSINESS

A. Transylvania County Comprehensive Housing Study Community Engagement and Housing Survey Report

Mr. Adams presented the Report and reviewed the main takeaways from the stakeholder meetings and interviews. Mr. Privette expressed his concern over the 'barriers' found on page 18 of the report, over 'un-collected tax revenue due to heirs' property' and 'low taxes compared to the rest of the region,' stating that the County collects something like 99% of its taxes. Mr. Adams said he was under the impression that these were collected comments from the 36 stakeholders present at the meetings at that they were likely referring to improvements of the heirs' properties and the relative percentage of taxes that could be collected on residential properties, as opposed to the more commercially and industrially oriented revenues of neighboring counties. Mr. Adams said he would provide this feedback to the consultant team and ask for clarification. <u>Mr. Privette moved to approve the recommendation of the study to the Board, with the stated clarifications, Mr. Jackson seconded and the Board unanimously approved.</u>

#### VI. INFORMATIONAL OR DISCUSSION ITEMS:

#### A. Subdivision & Exemptions Update

Mr. Adams provided the staff report for the Planning Department's recent approvals. During the month of October, the department approved 6 total exemptions and 6 subdivisions.

#### B. Transportation Update

Mr. Adams provided recent ridership statistics for the Transylvania County Public Transportation's fixed route and demand response services. There were over 100 riders for the Fixed Route service in October, outpacing 2024 total. The Demand Response service was well below previous years for September, and it is expected October will also be down, due to the recent storm event. Mr. Adams, also explained that the Transportation Advisory Board (TAB) has asked to extend the survey of public transportation services, with plans to re-route the fixed-route system in FY26.

#### C. Housing Study Update

Mr. Adams announced TPMA's housing study survey and recently recommended engagement report would be forwarded to the Board of Commissioners for their consideration.

#### D. Community Appearance Initiative Update

Mr. Adams announced that the Hamilton project is still awaiting a signed agreement for clean-up.

#### E. Transylvania 2050 Comprehensive Plan Update

Mr. Adams explained the amended timeline for the 2050 Comprehensive Plan. His goal is to have the revised community survey ready for next month's review and released to the public in the coming year. The report from the data collected so far will likely be available to the board next month.

VII. **PUBLIC COMMENT:** (15-minute time limit. Speakers are limited to three minutes.) There was no public comment.

- VIII. BOARD MEMBERS' COMMENTS: There was no comments by the Board. <u>Mr. Privette</u> moved to adjourn the meeting. Mr. Cochran seconded the motion. All present members voted in favor and the meeting adjourned at 7:28 PM.

#### Background

Lisa Fletcher, on behalf of the Transylvania County Board of Education, is seeking assistance in the removal of debris and hazardous materials from the 0.48-acre property at 41 Confederate Lane, accessed and visible from Little Egypt Rd. (State Road SR-1185). The property was declared a nuisance property and a potential site for workforce housing earlier this year. Solid Waste, Environmental Health and Planning Department Staff met with School Board representatives on November 12, 2024, for a site visit and an inspection of the property.

The property, as found in the accompanying pictures (A-3), is in a dilapidated condition, with all manner of junk and hazardous debris distributed throughout the property. The property offers many signs of being utilized as an illegal substance production facility and may still be an active site, as signs of illegal

trespass, drug paraphernalia and recent use are in evidence. Due to the nature of the hazards involved with this location, staff reached out to the Sheriff's Department to investigate whether there had been any recent reports involving this site.

The Sheriff's Department response (B-2) states that thousands of reports have been filed on the property and it continues to cause community concerns. The Sheriff's Department also requested that if approved for demolition or removal that the site be considered for training opportunities.

The site is served by a shared well and septic. Environmental Health's site analysis is attached (B-3), which explains the limitations of the current septic system. The School Board is currently working with the Transylvania Home Trust to convert a site in the Town of Rosman for three workforce housing units and is hoping to convert this site, once cleared, for teacher and public employee housing and has included a cost estimate below.

#### **Proposed project costs:**

#### Notes:

- The Board of Education has been quoted by the Housing Authority an estimate of \$77,000 for total project costs (e.g. demolition, new well, grading, landscaping and septic)
- Solid Waste's estimate of tipping fees reflects the volume of junk which can be processed by the landfill and does not include any metal from the mobile home or junk metal associated with the cleanup.

#### **Applicable Criteria**

#### TRANSYLVANIA COUNTY COMMUNITY APPERANCE INITIATIVE

#### **GOALS**-

The goals of the Transylvania County Community Appearance Initiative (CAI) are:

- Preserve and protect the natural beauty of Transylvania County
- Promote and protect property rights
- Promote and protect the health and safety of Transylvania County
- Promote economic development while protecting individuals and businesses from burdensome regulations.

**Staff comment:** Although the property is only slightly visible from the Little Egypt roadway, the project would preserve and protect the natural beauty, protect surrounding property rights and protect the health and safety of the entire county, by converting a known production facility for illicit activities, into one of the county's most needed assets.

#### **MISSION-**

*Transylvania County will assist citizens to remove and dispose of abandoned manufactured housing, junked / abandoned motor vehicles and junk.* 

The County will help identify areas for improvement, coordinate efforts and may provide financial assistance in some cases to aid in this effort.

**Staff comment:** The mobile home in question is a safety hazard, and the property remains a possible facility until remedial action is taken.

#### **SCOPE AND PRIORITITES-**

The initiative will apply to abandoned manufactured homes, junked / abandoned motor vehicles, junk and junkyards visible from state roads. Priority will be given to safety and health and to the major corridors in the County; U.S. 64, U.S.178, U.S. 276, NC 215 and NC 280, but shall include all property visible to an NCDOT state-maintained public right-of-way in Transylvania County.

**Staff comment:** Although not on a major scenic corridor (see supplemental picture, below), the junk and mobile home can be seen from Little Egypt Road, which is a NCDOT state-maintained public right of way.

#### **DEFINITIONS-**

*Junk:* Wrecked, scrapped, disassembled, unusable, cannibalized, inoperable, or un-repairable boats, trailers, camping trailers, construction equipment, appliance, vehicle parts, *building materials, scrap metal, rope, rags, paper*, and rubber.

**Staff comment:** The mobile home should be demolished and the hazardous materials should be removed due to safety concerns.

#### STAFF RECOMMENDATION

The Technical Advisory Committee recommends this property to the Planning Board for consideration and approval, upon the following conditions:

1. Staff will work with the property owner to obtain agreements and waivers of liability to implement the improvement effort.

- 2. Limitations or conditions to be placed on the agreement:
  - a. Time period for cleanup and pick up date of box;
  - **b.** Not to exceed amount of County funds;
  - **c.** Others?





The purpose of this letter is to inform you of the involvement of the Transylvania County Sheriff's Office in this matter. Transylvania County Sheriff's Office began having issues at 41 Confederate Lane several years ago. The issues were primarily drug-related or the results of the consumption of illicit substances.

Over the course of several years, the calls for service increased and it was not uncommon for patrol deputies to respond to this address several times a week for various issues. The issues included drug usage and sales, prostitution, fugitives, breaking and entering investigations, stolen vehicles, public displays of sexual acts, prowlers, etc. We have also done multiple search warrants at this address as well.

Due to the overwhelming number of calls to this residence and the fact that this was a nuisance property we were able to work with the North Carolina Department of Alcohol Law Enforcemet's Nuisance Abatement team and have the property deemed a nuisance and for lack of better term shut down.

The neighbors of this property dealt with a tremendous nuisance over the years and deserve to live a peaceful life free from drugs and the results thereof.

Hey Jeff,

This is Neill in Environmental Health. Letting you know that I can not find the septic record for this lot. I did go back out to the site and located the septic tank and one gravel drainline. It looks as though there may be damage to the septic tank, or it was having some kind of problem in the past. I would advise to budget a septic repair for this lot. The repair may be just a tank replacement, or it could be a full repair (including new drainlines). I have included a site sketch I did while on the site yesterday that may aid in deconstruction of the house. Before a new house is built or placed on the site we will need to do an existing system inspection. At which time, the top of the septic tank will need to be uncovered to check its structural integrity. General setbacks for the new home are 5' minimum off any part of the septic system and 25' minimum off the well. I love the idea of this project, let me know if I can do anything to help.

The second method will employ a randomized quasi-scientifically controlled replicate of the general survey sent through the US Mail system.

> The Draft Survey incorporates a shortened version of the Draft Survey developed over a series of Planning Board meetings throughout the past year, by the Planning Board and staff. This version reflects input from the County Manager's office and is built on various community survey instruments that were reviewed, analyzed and developed for Transylvania County.

In the Planning Board's March 2024 Draft (ATT 2), the sections removed have been highlighted and the language added are shown in red.

#### Transylvania County Transportation, Planning & Community Development January 2025

#### Transylvania 2050:

The Draft Summary of the Kick-Off & Community Center Engagement was approved for release and inclusion in the Transylvania 2050 Comprehensive Plan Update. The Draft of the Community Survey was forwarded to the Planning Board's January Meeting, for their consideration and recommendations for general release.

#### Transylvania County Comprehensive Housing Strategy:

County Staff's next meeting with TPMA will be January 22nd to discuss the latest draft of the Stakeholder Engagement Summary and Findings so far.

#### Asheville Regional Housing Consortium (ARHC):

No update. Next meeting has not been scheduled, post-Helene.

#### Land of Sky Regional Housing Alliance (LOSRHA):

The LOSRHA met on January 8th on Zoom. The group will transition to seeking resources and funding for long term storm recovery and ways it ties into the existing affordable housing needs. The group's focus this coming month will be drafting a regional needs document to be used for storm recovery advocacy and funding requests.

**Brevard-Transylvania Housing Coalition (BTHC):** The BTHC met on December 17th at Grace Church Brevard. The group is now refocusing on pre-storm affordable housing needs instead of storm recovery efforts. The City of Brevard and various nonprofit organizations are working on affordable housing projects. The County provided the following update on its infrastructure investments:

- <u>Brevard- Rosman Interconnect for Water:</u> The final bid has been approved by DEQ and is moving forward to contracting/construction. This project will allow for emergency sharing of water resources between the Town and City. The need for resilience infrastructure was emphasized in our region due to the storm impacts. Estimated completion in summer 2025.
- <u>Brevard Gallimore Road sewer improvements</u>: This project will allow the Boys and Girl's Club expansion to continue as planned while also improving a section of sewer infrastructure that serves approximately 30% of the City's customers, including a good portion of multifamily units in the southern portion of the city. The Boys and Girls Club is paying for the engineering and the county is funding construction and easement for this project and a sewer lift station project at the request of the City.
- <u>Extension of infrastructure to Pisgah Labs</u>: Transylvania County commissioners have approved the city's grant match at up to \$650k and to additional costs to complete the

project that the City's RDA recent grant award. The additional costs are preliminarily expected to be an additional \$700k in county funds. This project will support the Pisgah Labs expansion plans for pharmaceutical manufacturing including new job creation. Pisgah Labs has also been in discussions about building some housing at their site along the Ecusta Trail to support workforce in the future.

• There are several other projects in study or pre-development. Additionally, the state budget last year awarded the City of Brevard \$13 million, Town of Rosman \$10 million and the County \$10 million to be used for infrastructure. These are not expected to be repeat funding allotments in future state budgets. The City and Town are both completing their Asset Inventory Assessments and CIPs funded by state grants that will help show the big picture of the status of their systems, project needs and establish the baseline for future planning. Commissioners have requested these in order to deliberate on the best way to invest the \$10 million on behalf of the county as a whole and are tentatively scheduled to consider funding requests in the first quarter of 2025.

#### The Planning Board (PB):

The PB is scheduled to consider a tabled Community Appearance Initiative project and review the Transylvania 2050 Comprehensive Plan Update Draft Community Survey to be released to the general public in the coming months.

#### **Community Appearance Initiative (CAI):**

The CAI Team received the signed agreement for the Blythe Property for a 'not to exceed' amount of \$10,500 and is working with the Hamilton Property representatives to complete a project in Little River for a 'not to exceed' amount of \$6,700. The CAI Team has not received any new applications for funding, while CAI# 24-07, which was tabled in November and continued in December, will be before the Planning Board at their January meeting. The CAI has \$354.10 of available funds in the FY25 CAI budget remaining, pending expenditures.

#### The Transportation Advisory Board (TAB):

The TAB reviewed the changes to the Fixed-Route Survey recommended at their November meeting and approved the trimmed-down version for release to the general public. The route changing process involves removing and adding stops, getting property approvals for re-locating the stops and updating signage and stop facilities.

Silver Squirrels funding: Transylvania County Transportation received extended funding for an FY25 St. Philip's Episcopal Women's grant for \$10,000, which continues free senior transportation services for another year. The Silver Squirrels service provided 373 rides over the past quarter to seniors travelling throughout the county and region.

The County received funding from Pisgah Health foundation to extend the County's service to the outlying areas of the County, through its purchase of a new minivan in FY25. The County budgeted for an additional part-time driver to extend a pilot program, which accounted for 111 rides, which

recaptured \$4,780 of funding that would have gone to a third-party operator. While this is an improvement in the County's ability to provide ADA-compliant access to areas not normally reached by County-operated services, it is still just 17% of the new minivan's rides. Transportation staff will continue to on-board and reroute rides over the second quarter to capture more of the outlying area share in-house.

#### The Transportation Advisory Committee (TAC):

This month's TAC has been moved to February 11th, as the Comprehensive Transportation Plan for Transylvania County is still under state review.

#### Joint Historic Preservation Committee (JHPC):

The Inn at Brevard is back on the market. Staff have communicated necessary repairs to potential buyers.

Staff submitted an Annual Report of JHPC activities to the North Carolina Department of Cultural and Natural Resources on December 20<sup>th</sup>. This along with training sessions allows Transylvania County to maintain its status as a Certified Local Government (CLG) for historic preservation.

#### Transylvania 250 Committee

The America 250<sup>th</sup> Committee and staff have submitted their grant application for to the North Carolina Department of Cultural and Natural Resources funding for designated America 250 County Committees. This request will seek funding for a Colonial Garden construction at the Transylvania Heritage Museum and an Edenton Tea Party Reenactment in Rosman in 2025.

The next commemoration events are being planned for Spring 2025.

#### **Community Center Regional Leadership Group:**

Staff received a contract for review for a centralized booking and calendar software service, which is currently being reviewed by IT and County legal staff prior to approval and implementation.

#### **Community Center Grants:**

The Community Center Grant Review Committee met on December 10<sup>th</sup> and agreed to award ten Community Centers continuing and one new Connected Public Space Grants, for \$16,500. The Committee awarded ten grants for \$20,764 dollars for the Public Health/Safety Grants and nine Public Purpose Project Grants for \$45,000, for a total of \$82,264 in grant funding.

CC Grant Award Letters and Contracts were issued to Transylvania Community Centers on December 30, 2024 and signed contracts are beginning to be received by staff.
