- I. WELCOME: Mr. John Koury called the meeting to order at 4:05PM. Ms. Geri Connell, Ms. Nicole Bentley, and Ms. Nikki Ransdell were present. Two new members were also present: Ms. Chelsea Preciado and Mr. Samuel Hayes. Mr. Billy Parrish, Ms. Katherine Buzby and Mr. Andrew Wing were absent (excused). A quorum was present. A. <u>The Inn at Brevard</u>: The Inn at Brevard is planning to change ownership on November 15th. The eminent closing date was confirmed by Mr. Chandler Brewer, the real estate agent handling the sale. Staff will reach out to the new owners to touch base on repair requirements. The JHPC hopes to receive a Certificate of Appropriateness application prior to their meeting in January.

VI. NEW BUSINESS:

- A. <u>America: 250th Grant Project: Flower Trail:</u> Mr. Koury gave an update on the America 250th County Committee Grant. The committee has decided to apply for funding support for three projects as part of the 250th Commemoration of America's founding. The Heritage Museum is requesting funds for the construction of a colonial style garden. This garden will be open to all visitors and used in the educational programs that use the site. Ms. Pinkie Byrd will produce a reenactment of the Edenton Tea party. Part of the grant application will see funding for costumes and recording services for the event. The production will also be available for educational purposes. The third project is a 'Flower Trail'. This will consist of small metal signs placed at historically significant locations in Transylvania County. Artists will provide renderings of native flowers of North Carolina, that will be displayed on the signs, along with an informational QR code. The locations of the markers aim to highlight how democracy has grown and evolved since America's founding. Outside of the grant, the 250th committee will host an event to commemorate the Mecklenburg Address and school poetry contest in Spring of 2025. Staff have asked the JHPC for suggestions locations for the markers.
- B. <u>Staff Report</u>: The next regularly scheduled meeting on Tuesday, January 14, 2025, at
 4:00PM. Meeting room will be decided prior to the meeting, based on space availability.
